VPP Grant – HTUGRR Interpretive Trail

Tasks 1, 2, and 3 are completed. Maree is working on task 4, which is laying out the trail. Maree Forbes Gaughan shared a draft plan of the trail waypoints along with a map. Maree mentioned that once the viewing corridors are finalized, they will put together the story that connects the viewing corridor. Rich stated that the draft will be shared with the full Commission once the project is further fleshed out.

BVSB Chadds Ford Township Project

Kathleen stated that there is no update on the status with PennDOT.

AACHAF Grant Project for "The Pines"

Rich Phifer stated that the project is moving forward with two meetings scheduled at the Pines as part of the grant application project. The project is on track.

FHWA Grant Project for "The Pines"

Rich Phifer mentioned that work is moving forward on the Grant application. Maree stated that the November 27 deadline is looming, and 8 tasks need to be completed in the next month in order to meet the deadline.

Resolution for Local Share Assessment Grant Fund Opportunity.

Rich Phifer presented an opportunity for a Commonwealth Financing Authority grant through the DCED that requires no matching funds. It is the Local Share Assessment Statewide grant program. Applications are due in late November and restoration/construction work at The Pines would be eligible. The DCED funds could be used to match potential FHWA grant funds.

Rich presented a Resolution that if approved by the members would enable the Commission to submit a grant application. Rich has not heard officially from Kennett Township that they have reviewed the grant application opportunity. Given the time sensitive nature of the grant deadline, Rich Phifer made a motion that the Commission authorize the resolution for application for a Local Share Assessment Grant Fund opportunity seeking \$100,000.00, subject to Kennett Township's approval and with the

understanding that a \$100.00 application fee would have to be paid by the Commission. Kathleen seconded the motion. The motion carried with all in favor.
